Group Contributions:

\$676.77 in group contributions were collected during April 2023 from Oddballs and Lunch Bunch groups. There was a \$27.90 contribution that was received from a Fruita Group but actual group was not marked on the check. I credited that to As Bill Sees it Group. We also received a \$400 check from another group, however check was return as personal checking account had been closed. I'll work with that group to make good on \$400 contribution and \$7 return check fee charged to District 2 before the end of the month. We also have received a \$300 cash distribution from Sisters in Sobriety that will be deposited before the end of the month. Total Group Contributions collected to date is \$1,048.27 plus \$100.00 in contributions from the Gratitude Dinner brings total contributions to \$1,148.27 for 2023 representing 23% of contributions budgeted in 2023 (\$5,000). With additional \$700 in group contributions anticipated during

June 2023, its anticipated District 2 will be at 37% of contributions budgeted for the year. This marks a much improved financial picture for District 2 over where we were last month where contributions represented only 9% of this year's budget.

Expenses during April 2023 included \$16.08 for Zoom subscription, \$300.00 to reimburse Don D for attending Area 10 Spring Assembly, \$30 reimbursement to CPC/PI Committee and \$28.22 reimbursement to Events Chair for AA Service Workshop and Delegates Report. Total expenses in May 2023 was \$381.30. Total expenses for the year is \$988.46 representing 19% of expenses budgeted in 2023 (\$5,000).
