Treasurer's Report: CURRENT ACCOUNT STATUS: Checking Account: \$5,321.50 - Checking Account Balance as of August 31, 2023. Prudent Reserve Savings: \$1,000.57 - Current Savings Balance (Prudent Reserve) as of August 31, 2023. I've attached

Total Group Contributions for August 2023 were \$677.17. We also received a \$100 contribution from the Saturday Morning Women's Group in early September. Total Group Contributions collected to date (including September) is \$2,230.80 plus \$100.00 in contributions from the Gratitude Dinner that brings total contributions to \$2,330.80 for 2023 representing 47% of contributions budgeted in 2023 (\$5,000). With 3 months to go, District 2 is on pace to collect \$3,107.50 in contributions well below \$5,000 that was budgeted for 2023. Expenses: Expenses during August 2023 included \$87.15 for CPC/PI Committee, \$16.08 for Zoom subscription, \$63.54 for Delegate Report, \$24.40 for Special Events and \$23.17 for printing of Meeting Lists. Total expenses for the year is \$2,071.48 representing 39% of expenses budgeted in 2023 (\$5,000). I have already made reimbursements in September of \$162.00 and expect to reimburse Don D for Heather and him to attend the Area 10 State Convention \$300.00. I also anticipate \$600.00 in additional expenses for Co-CDM's to attend Winter Conference. That brings anticipated expenses for 2023 to \$4,169.49. We discussed 2024 budget during August's District 2 meeting and finalized budgets for all officers and committees with the exception of Archives. There is also the question of purchasing a new printer for Meeting Lists Committee that we'll also need to discuss during tomorrow's District 2 meeting. I've attached a tentative budget that I'll update after our discussions on Sunday and then present at October's District 2 Meeting. From there, GSR's will want to take District 2's budget back to their groups to discuss. I will also be available after October's District 2 meeting to attend various group business meetings to answer any questions as well. Final budget will be presented for official adoption by District 2 members at the November meeting. Let me know if you have any questions!

pass on some solid sobriety, program and principles, but it was a wonderful unifying experience for our district. We are so grateful to the committee and participants for their service. District Inventory Report (Heather)- The inventory began at 3 and ended about 6 p.m. Sunday Sept. 17th. This report endeavors to capture the essence of the discussion, from notes taken by the CoDCM's.Scott M, who has served as a Past Area 10 Delegate, and in numerous group, district, and area positions, came for the day from the Denver area at his own expense to effectively "sponsor"/guide us through what is essentially a 5th Step for the District. His guidance was to look deeply and honestly, and to consider our effectiveness within the framework of our Primary Purpose. Rather than specifically addressing some of more narrow questions we had listed, he approached the process more globally, using our Primary Purpose to Carry the Message as a starting point – framing it in terms of: what is our message? • What is our message to the district members, and should we consider this as something different than just the AA message. • Unity: especially following the effects of the pandemic upon groups and district • Serve GSRs – they are the link to the fellowship through the groups and thus have a key role in unity and communication. Are we doing the best job there? • Our district is currently very active, PI/CPC is very

strong and building relationships in the broader community - very effective in efforts to carry the message. • Hispanic meeting, and how do we as a district help facilitate this. • Most committee chair positions are currently filled; rotation in November will leave a couple of open positions. • One district member commented that the district is more active than he's seen in a long time. • DCMs support GSRs so that they in turn can support their groups – effectively acting as service sponsors for the district and groups respectively. • Need more GSRs and Alt GSRs for groups not currently represented at the district. • Things districts perform: 1. Drive potential members to groups, 2. Communicate up and down the general service triangle, 3. Service sponsorship of GSRs. • Breakdowns in communication through the service structure happen at the DCM and GSR levels. Once GSR has information – what they do with that is key. • Sometimes groups don't respond to something that is coming up through the inverted triangle. • Breakdowns can also occur with rotations – Scott mentioned that GSRs typically don't last through their entire 2 year rotations (usually lasting only 6-9 months). • Communication should occur from one group to next – GSRs - DCMs - Area - GSO • It comes down to 2 of us against the problem - where does God want us to be? • Difference between us and problems that occur in larger society is that if we don't fix problems we die. • A worksheet/cheatsheet for GSRs providing guidance on basic responsibilities, etc. would be helpful. Something we could upload so it's downloadable for new GSRs. • Bullet points for the GSR'S of what is in the emails from DCMs so they can decimate what is important for their group and not. • There is a disconnect from the groups to general service, in people seeing the importance of the service structure up to GSO. • If not communicating, things break down – especially when groups start independently going to treatment, jails, etc. without coordination through the district - relationships with those institutions break down. • How are DCMs getting out to groups. Currently responsibilities are split between the two dcms - one goes to groups, the other largely takes care of administrative pieces. • What percentage of groups are participating in the district – about 50%. Scott remarked that that is actually good participation relative to other districts. • Communication with groups Lot of material comes through to DCMs from GSO and Area. How to help GSRs determine which materials and how to disseminate in a way that's effective and useful, and encourage their group members to attend group business meetings. Discussion of strategies to lay out the materials more clearly and issues that arise in too much editing. Groups determine what want from DCMs – maybe GSRs could provide more information on what their groups interested most in receiving info about. • So, this is the Inventory – now, we report back – bring discussion back at district. District then discusses how and what to focus on. • Maybe do a Communications Workshop (we have an AA 101 Workshop in Oct.) • Do the groups know they can attend district meetings, and where and when? How can we do better with communicating this? Why would we want our group members to attend district meetings? How can we best get the message out that district is available - that they can attend and that district officers can go to their meetings and talk about what district does? • How to communicate with groups - maybe a prepared Powerpoint, go to groups and give mini-service structure presentations? Website, calendar or something via internet to post things on that are happening around the district. Treatment programs have impacted AA and how people perceive AA. Things have changed in ways that cause long-timers to disengage, have impacted our primary purpose, have taken meetings more into support therapy sessions rather than focusing on what AA is. How do we confront that. Make business meetings at group and district level fun, with food, etc., and more available. Point made that everyone who serves in general service works hard and is committed. • How can DCMs work with the GSRs to do group inventories, and bring excitement of service to groups. • Our 2 upcoming assemblies are opportunities to bring more excitement about our fellowship and service. Make these our focus to reinvigorate the district? (Comment made that we are the only district in remembered history that has hosted 2 assemblies in one year). • Get everyone excited and involved with the upcoming assemblies that are going to be here. How do we do that, ad-hoc committee or something else? Purpose is to make people aware of service. • How do we address other, non-AA recovery-based initiatives that focus on fun activities, etc. (e.g. Peer 180) • District has hands full with our current activities. We already do a great job of hosting fellowship building events, the events are fun. • Assemblies can be effective in showing fellowship how they can serve – as a kind of service "job fair". Our committees should be represented there; people can then come and decide how and where to stand. • It is a lot of work. • Didn't address more specific questions. Scott is available in person or Zoom for a part 2 follow-up. • What topics need to be discussed before our next meeting with Scott from this inventory and what needs to be covered by Scott in our next inventory meeting.
